Sudur Paschim Province Baseline Multi-Indicator Survey-2076

1. Government of Province (GOP) has allocated fund from government budget toward the cost of **Sudur Paschim Province Baseline Multi-Indicator Survey-2076** and intends to apply a portion of this budget to eligible payments under the Contract for which this Expression of Interest is invited for National consulting service.
2. The Ministry of Economic Affairs and Planning now invites Expression of Interest (EOI) from eligible consulting firms/companies (“consultant”) to provide the following consulting services: **Sudur Paschim Province Baseline Multi-Indicator Survey-2076**
3. Interested eligible consultants may obtain further information and EOI document free of cost at the address Ministry of Economic Affairs and Planning, Sudur paschim Province, Dhangadhi, Kailali within 15th day of the Date of First Publication during office hours or visit the client's website **moeap.p7.gov.np** or visit e-GP system <https://bolpatra.gov.np/egp/>
4. Expressions of interest shall be delivered online through e-GP system <https://bolpatra.gov.np/egp/> on or before **2076/05/13, 12.00 Noon**.
5. The consulting firms/companies can apply either in single or in Joint Venture (JV). The number of consulting firms/companies in a JV shall not exceed **three** including the lead firm/company. In addition, same consulting firm/company is not allowed to enter into more than one JV for the Job.
6. The EOI documents received shall be opened at 14:00 (NST) on the 16th day of date of first publication of this notice in the presence of the applicants or the authorized representatives whosoever wish to attend. Absence of the applicants or their authorized representatives, however, shall not obstruct or prevent the opening of the EOI in anyway.
7. In case the last date of obtaining and submission of the EOI documents happens to be a holiday, the next working day will be deemed as the due date but the time will be the same as stipulated.
8. EOI will be assessed based on **Experience of Consulting Firm (40%)**, **Capacity (of Consulting Firm (10%))** and **Qualification and Experience of Key Personnel (50%)**. Based on evaluation of EOI, only shortlisted firm/company will be invited to submit technical and financial proposal through a Request for Proposal (RFP).
9. Minimum score to pass the EOI is 60 percent of the total EOI marks. Applicants obtaining at least 60% marks in the EOI evaluation process shall be considered as qualified firms/companies. Only top six out of such qualified firms/companies will be shortlisted and allowed to participate in Request for Proposal (RFP) Process.
10. RFP for this job will be subsequently issued to the shortlisted firms/companies. The Quality and Cost Based Selection (QCBS) procedure will be used for final selection of the consulting firms/companies, based on technical and financial proposals.
11. MOEAP reserves the right to accept or reject any or all EOI applications with or without giving any reason whatsoever.
