Province Government of Sudurpashchim province Ministry of Economic Affairs has allocated funds towards the cost of Construction of Administrative Building of Ministry of Economic Affairs and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Administrative Building Ministry of Economic Affairs Bidding is open to all eligible as per Section V of bidding document.
2. Province Ministry of Economic Affairs invites electronic bids from eligible bidders for the construction of Construction of Administrative Building of Ministry of Economic Affairs under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 3,69,00000.00
  - Minimum Work experience of similar size and nature: 1 number of of 2 storey Steel structure prefab public building of at least NRS 1,97,00000.00 that have been successfully or are substantially completed and that are similar to the purposed work.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
